Top two vote getters will serve a four-year term and the candidate receiving the third greatest votes will serve a twoyear term filling the seat vacated by Zareh Sinanyan in 2019.

Candidate Forum and the New Council

On March 3 Glendale voters reelected Councilmember **Paula Devine** and sent two new members, Ardy Kassakhian and Dan Brotman, to the dais to join colleagues **Ara Najarian** and *Vrej Agajanian*. What did the newly elected Council members say at our forum?

On January 23, which only *feels* like a hundred years ago, our HOA co-hosted a City Council Candidate Forum with the Dads' Club. More than eighty people attended to hear former Glendale Mayor **Frank Quintero** ask all *eight* candidates about their position on issues of importance to Glendale neighborhoods. Questions came from members as well as the HOA Board.

All three winners expressed opposition to poorly written state mandates that force Glendale and other local governments to change their current ADU laws and don't sufficiently protect older, historic neighborhoods. (The Verdugo Woodlands West HOA Board played an outsized role in crafting Glendale's first ADU ordinance, which became a model for other cities). They support stricter application of design guidelines to help preserve neighborhood character. Brotman said that the design review process "is broken;" he identified a need to appoint qualified people to commissions and boards, as did Kassakhian, who also advocated for a citywide historic resources survey so that we have a better sense of the character we want to protect. Devine spoke to her record of supporting several neighborhood appeals of out-sized and incompatible projects.

All successful candidates enjoyed endorsements from the Sierra Club and are advocates for a greener Glendale. Devine observed that Glendale is hiring its first Sustainability Officer. Kassakhian proposed a citizens environmental commission to keep Glendale focused on climate and the environment. Brotman noted that he spearheaded opposition to expanding the all-fossil-fuel Grayson Power Plant and succeeded in getting the City to rethink that plan while saving taxpayers \$175,000. Although it would get people out of their cars, Brotman and Kassakhian dismissed the proposed streetcar along Brand Blvd. as too expensive and urged consideration of more cost-effective measures, including improving the Beeline. All three candidates support the long overdue comprehensive traffic study.

The final four questions of the evening were yes or no, hands up or hands down, without comment. Brotman, Devine, and Kassakhian voted "yes" to

- requiring staff report to Council on the costs/benefits of the Americana:

- supporting a ban on two stroke gas-powered leaf blowers in Glendale;

- asking staff to come to Council with a proposal to limit construction of ADUs in hillside areas at high fire risk and with narrow streets, as permitted under State law;

— requiring that development projects in the Downtown Specific Plan (DSP) area, which currently go straight to Council for approval, must first go to the Design Review Board and Planning Commission.

Indeed, they are already making good on the last promise. A few weeks ago Brotman moved, with Kassakhian seconding, that staff return to Council with a proposal for sending DSP projects to the appropriate commissions and boards before they come to Council for final approval.

We express deep gratitude to our new and reelected Council Members for serving during this particularly difficult time and look forward to seeing what they can do for Glendale.

Objections to Lights in Verdugo Woodlands West Street Lamps


The HOA Board has been in touch with staff at Glendale Water and Power about replacement bulbs that have been installed within some our neighborhood street lamps, both the historic post top lights and the newer cobra-head luminaries. Residents have complained about the too-bright blue bulbs, which our eyes read as white, rather than the softer yellow that we are used to. The American Medical Association recommends against such bright blue lights, which can interfere with sleep and are potentially dangerous for drivers and pedestrians. They can also impact the nocturnal wildlife that is so plentiful in the Woodlands.

GWP staff have suspended installation of the new bulbs and are seeking a softer bulb with a lower color temperature. We will follow up with them to ensure an attractive and safe nighttime environment.

Summer Color

Those of you who regularly walk down Bonita Drive have undoubtedly noticed the abundance of colorful flowers in front of the home owned by our relatively new neighbor, Donna Fitzpatrick. After living in the Rossmoyne area for over 45 years, where she and her husband raised their two daughters, Donna purchased her Verdugo Woodlands home in February of 2019. She immediately started working on the garden we all get to enjoy today.

We asked Donna if she had any tips for us who are "plant challenged." It was obvious this was her favorite subject and she enthusiastically shared that her favorite annual at this time of year is the Supertunia which comes in an unending variety of colors. She also recommended planting two of her favorite perennials, the Shasta Daisy and Hydrangeas. She advised that her secret to having consistent healthy blooms is that she uses Proven Winners water soluble fertilizer, applying it every third watering. She orders this online from Amazon since the local nurseries don't carry it. Her favorite local nursery is Armstrong's in La Crescenta. She also shared the fact that when she has a plant or combination of plants that performed exceptionally well, she takes a picture and saves it to her Garden board on Pinterest so she can be reminded the following year.

We hope this encourages you to get out there and plant some flowers! Donna generously offered to give additional tips to anyone who wants to stop by and chat (six feet apart and masked of course).






